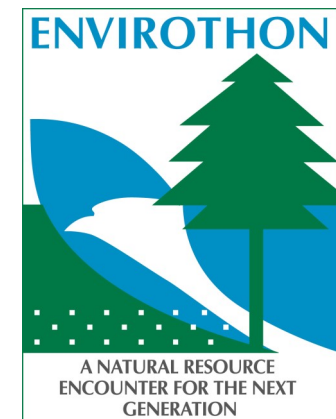

They were: Chicksaw-Shiloh RC&D, Clinch-Powell RC&D, Five-Rivers RC&D, Hull-York Lakeland RC&D & Southeast Tennessee RC&D.

## Tennessee League of Resource Conservation & Development Associations

The first statewide meeting was held **Dec. 4 1977** to consider the formation of a Tennessee Resource Conservation & Development Association in Nashville Tennessee. Beverly Price (Five-Rivers) was elected to serve as temporary president of what would become the Tennessee League of RC&D Associations.

At that time there were four (4) RC&D Councils in Tennessee. They were: Chickasaw-Shiloh RC&D Council, Five-Rivers RC&D Council, Hull-York Lakeland RC&D Council, and Southeast Tennessee RC&D Council.
